CONSTITUTION and BY-LAWS

of the

SCANDINAVIAN COLLECTORS CLUB

Article 1

- Sec. 1 This club shall be known as the SCANDINAVIAN COLLECTORS CLUB.
- Sec. 2 The object of this club shall be to promote and encourage an interest in, and an appreciation of, all things philatelic pertaining to the Scandinavian Countries and to unite our membership in an organization where mutual respect and cooperation predominate.

Article 2

- Sec. 1 Membership in this club shall be open to anyone over 18 years of age who is or has been a bona-fide collector of philatelic material of any of the Scandinavian countries or is a student of Scandinavian philately. Membership shall be open to those under 18 years of age, providing a parent or guardian acts as guarantor and providing further that such parent or guarantor furnishes two sufficient references acceptable to the Board of Governors.
- Sec. 2 Membership shall consist of active, associate, honorary and life members. Active members shall be any resident of the continental United States. Associate members shall live elsewhere in the world. Active and life members shall have voting privileges.
- Sec. 3 Honorary membership shall be conferred on those persons who merit such honor by reason of outstanding achievement in Scandinavian philately and whose philatelic activity has benefited the club. Candidates for honorary membership shall be proposed to the Board of Governors in writing, signed and endorsed by not less than five (5) members in good standing. If honorary membership is then recommended by the Board of Governors, the election to honorary membership shall be voted upon by the members at a regular meeting and a two-thirds ($\frac{2}{3}$) affirmative vote of the members present shall be necessary for election. The number of honorary members at any time shall not exceed eight (8) or $1\frac{1}{2}$ per cent of the total membership of the club, whichever is larger.
- Sec. 4 Life-membership may be secured upon payment of \$40.00 by an active member and \$20.00 by an associate member.
- Sec. 5 All prospective members, active or associate, shall make application in writing to the club. Such applications must be reviewed by the Board of Governors and presented by them together with their recommendation at the next regular meeting of the club. A $\frac{2}{3}$ affirmative vote of the members present shall be necessary for election to membership.
- Sec. 6 Membership in the club may be terminated at any time upon written notice to the Secretary, provided the member is in good standing. A member may be suspended or expelled upon recommendation of the Board of Governors and by a $\frac{2}{3}$ vote of the members present at a regular meeting.

Article 3

- Sec. 1 The officers of the club shall be a President, Vice-President, Secretary, Treasurer, Librarian, Editor and three (3) members of the Board of Governors. All officers shall be elected for a term of one year, except that the members of the Board of Governors shall be elected for a term of three years, with one of the members of the Board of Governors elected each year.
- Sec. 2 The Board of Governors shall consist of the President, Vice President, Secretary, Treasurer and the Members of the Board. The three most recent Past-presidents shall be ex-officio members of the Board without vote. A quorum of the Board shall consist of four (4) voting members.
- Sec. 3 The duties of all officers shall be those usually associated with their respective offices. The Editor may appoint one or more Associate Editors.
- Sec. 4 The President shall appoint a nominating committee of three at the regular meeting in October of each year. The nominating committee shall report its slate of officers at the regular meeting in November, at which time the secretary shall be authorized by the Board of Governors, to have ballots printed and mailed to the membership. Proxy blanks shall also be included in this mailing, enabling the absent membership to participate in business at the annual meeting in January.
- Sec. 5 At the annual meeting in January, further nominations for each office may be made from the floor. Election of officers shall be by majority vote of ballots cast by members in good standing, and newly elected officers shall assume their respective offices immediately after the completion of the election.
- Sec. 6 The Treasurer shall submit a written report at the annual meeting of the club, such report and records to be audited by a committee appointed by the presiding officer.

Article 4

- Sec. 1 Regular monthly meetings shall be held on the fourth Thursday of each month at the quarters of the club in Chicago, Ill. If the date of any regular meeting shall fall on a holiday, such meeting shall be held on the first available date thereafter.
- Sec. 2 The annual meeting of the club shall be held on the fourth Thursday in January each year.
- Sec. 3 The Board of Governors shall have the right to suspend any meeting of the club if in their judgement the best interests of the club will be served by such suspension.

Article 5

- Sec. 1 The club is empowered to have local chapters thereof in various parts of the world. The location of the chapter, the scope of the territory covered by such chapter, and the delegation of powers to the officers of that chapter shall be determined by a majority vote of the Board of Governors of the Club. However, no chapter may be established unless there is before the Board a petition signed by at least 10 members desiring to establish such a chapter. Each officer and member of a chapter must be a member in good standing of the Scandinavian Collectors Club.

- Sec. 2 The President of any local chapter shall be considered a regional Vice-President of the Scandinavian Collectors Club with authority to meet with the Board of Governors at their regular or special meetings and vested with full powers.

Article 6

- Sec. 1 Dues shall be \$3.00 annually for active members or associate members, payable in advance. An initiation fee of \$1.00 must accompany all applications for admission to the club.
- Sec. 2 Chapter dues shall be established, collected and retained by said chapter.
- Sec. 3 Any member in arrears for one year shall be ineligible to vote or hold office. Non-payment of dues for a period of two years shall make the expulsion of such member mandatory.

Article 7

- Sec. 1 These by-laws may be amended by a $\frac{2}{3}$ vote of the members present at any regular or special meeting, provided notice of such proposed change shall be incorporated in the notice of the meeting.
