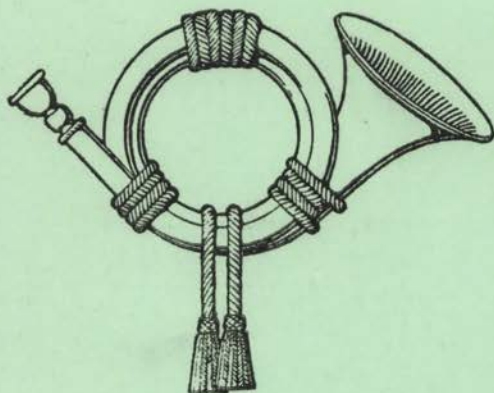

## SCANDINAVIAN COLLECTORS CLUB

As one of the older "specialty clubs," the Scandinavian Collectors Club has developed from a small group of Scandinavian-interested collectors in the New York area (1935) to a large, international society with members in all parts of the North American continent and in several European countries. Currently (1969) the membership is about 700 and increasing rapidly.

To many of the collectors who specialize in the stamps of Scandinavia, or collect them on a general basis, the S. C. C. offers a number of benefits, in addition to being a vehicle for the promotion of friendship and understanding between people of different backgrounds and nationalities (languages).

The strong bond is of course a deep interest in the stamps and all philatelic matters pertaining to Scandinavia—Denmark (including Danish West Indies and Greenland), Finland (including associated areas), Iceland, Norway, and Sweden. Whether a beginner in the collecting of these areas, or an advanced collector with years of experience, ALL benefit from membership in S. C. C.

S. C. C. has active chapters in many locations: Seattle, Washington (Chap. 1)—Philadelphia (Chap. 2)—Detroit, Michigan (Chap. 3)—Chicago, Illinois (Chap. 4)—New York (Chap. 7)—South Jersey (Chap. 8)—North Jersey (Chap. 9)—Toronto, Canada (Chap. 10)—Reykjavik, Iceland (Chap. 11)—Washington, D. C. (Chap. 12)—Delaware (Chap. 13)—Twin City, Minnesota (Chap. 14)—Rochester, New York (Chap. 15)—South Mississippi (Chap. 16)—Los Angeles, Calif. (Chap. 17)—Memphis, Tenn. (Chap. 18). More chapters are formed as the membership increases, and the required number of members in different localities request them. The chapters meet monthly, and offer interesting and educational program to those who attend.

S. C. C.'s official publication is **THE POSTHORN**, which is published six times per year and is mailed free to all members (non-members may subscribe at a rate of \$3.00 per six issues) and contains valuable information about old and new issues of the Scandinavian countries, such as papers on research studies regarding printing, plates, postmarks, and other specialized matters, as well as historical notes and articles of general interest, including reports on the Club's activities to promote and further interest in Scandinavian philately.

Philatelic literature from the Scandinavian countries, so much needed for enjoyable and intelligent collecting, is available—to anybody—from the **SCANDINAVIAN PHILATELIC LITERATURE SERVICE** (Box 175, Ben Franklin Station, Washington, D. C. 20044).

Members of S. C. C. may also use the services of the **SCANDINAVIAN STAMP MART**, a system for selling and/or buying of Scandinavian stamps by the members. Sales books are sent to individual members, or to chapters to be available at their meetings, and offer excellent opportunities for securing much-wanted stamps not usually available from other sources.

The services of S. C. C.'s **COUNTERFEIT COMMITTEE** are also available to members, and may well be the most practical way to obtain assistance in this field.



# BY-LAWS

## of Scandinavian Collectors Club

Adopted Jan. 25, 1968

### Article 1: Name and Purpose

**Section 1.** This organization is known as Scandinavian Collectors Club, organized in New York, N. Y., Nov. 25, 1935, and incorporated in the State of Illinois as a non-profit corporation on April 26, 1960, and is herein referred to as the Club.

**Section 2.** The purpose of the Club is to promote and encourage philately generally, and Scandinavian philately specifically, anywhere in the world.

### Article 2: Membership

**Section 1.** Membership shall be open to any person of good character with an interest in Scandinavian philately. Those under 18 years of age must provide a parent or guardian who will act as guarantor for the minor and furnish such safeguards as required by the Board of Governors.

**Section 2.** Membership shall consist of Active, Life, and Honorary members.

**Section 3.** An Active member in good standing is one who is current in his membership dues, has no overdue outstanding obligations to the Club, and against whom no action is pending.

**Section 4.** Life membership is available to members on payment of 20 times the annual dues. Life members shall have all the rights and privileges of Active members.

**Section 5.** Honorary membership may be conferred at the discretion of the Board of Governors on any person for outstanding achievement in Scandinavian philately or for activities extraordinarily benefiting the Club. Nominations for honorary membership must be made in writing to the Secretary, and be signed by at least six members in good standing.

**Section 6.** Application for membership shall be made on a prescribed form and submitted to the Secretary with the required dues and one dollar (\$1) entry fee. In the event membership is denied, the amount submitted shall be promptly refunded.

**Section 7.** The annual dues for Active membership shall be three dollars (\$3), payable in advance. The membership year shall begin each January 1. Persons admitted to membership after July 1 shall pay only half of the annual dues for that year. No dues shall be required of Honorary members.

**Section 8.** Resignation by a member shall be made in writing to the Secretary, who shall take the necessary action, provided the member is in good standing.

**Section 9.** A member delinquent in his dues for a period of six months shall be ineligible to vote or hold office. Any member delinquent in dues for more than a year shall be dropped from the rolls, unless otherwise directed by the Board of Governors.

**Section 10.** A member may be expelled for actions unworthy of a stamp collector or detrimental to the Club. Such action shall be taken only upon a formal complaint in writing to the Board of Governors, and the accused member shall be given an opportunity to appear in person before the Board if he so desires, or to have a representative present his defense. Final action on expulsion shall require affirmative vote of two-thirds of the entire Board.

**Section 11.** Each member shall be given a copy of these By-Laws, as well as the current membership list.

### **Article 3: Organization—Officers and Administrative Personnel**

**Section 1.** The officers of the Club shall be a President, a Vice-President, a Secretary, a Treasurer, an Editor, and three Directors. Their term of office shall be two years, and they shall take office on the January 1 following election. In the case of vacancies, these positions are to be filled by appointment, as prescribed in Article 5. Directors whose term of office does not terminate at the time of adoption of these By-Laws shall complete their terms, and if such term does not coincide with an election under these By-Laws, it shall be extended to the next election.

**Section 2.** The Board of Governors, hereinafter called the Board, shall consist of the officers named in Section 1 and the immediate past President. Presidents of active chapters shall be considered Regional Vice-Presidents and shall be entitled to participate in Board meetings, with voting privileges.

**Section 3.** The President may appoint such administrative personnel and committees as may be required for the effective functioning of the Club, subject to approval of the Board. Such appointments may include an Executive Secretary, a Sales Manager, an Auction Manager, a Philatelic Literature Sales Manager, a Librarian, an Attorney, Auditors, and such other positions as may be necessary and practical. An honorarium suitable to the position and responsibilities involved may be set by the Board.

### **Article 4: Election of Officers**

**Section 1.** Voting for officers shall be by mail ballot, and election shall be by a plurality of the valid votes received. To qualify for this election, there must be at least as many votes cast as is required for a quorum for the Annual meeting.

**Section 2.** The President shall appoint a Committee on Nominations consisting of a Chairman and two other members. This committee shall name a slate of officers and present it in such time and manner as the Board may direct. The Board shall cause ballots to be sent to all members in good standing by first class mail by November 15 of the election year.

**Section 3.** Additional nominations may be made by mail to the Secretary, by a chapter, properly signed and attested by the President and Secretary of the chapter, or by individuals, signed by at least six members in good standing. Such nominations may be for an entire slate, or for any office or offices to be filled, and must be in the hands of the Secretary by October 15. The Secretary shall forward the nominations immediately to the Chairman of the Committee on Nominations for appropriate action.



**Section 4.** All nominees must signify to the Committee in writing their willingness to serve, before their names will be placed on the ballot.

**Section 5.** The President shall appoint a Committee on Elections, consisting of a Chairman and two other members, so chosen that they can conveniently meet to count the ballots. Members must return ballots to the Chairman of this committee to be in his hands by December 10 of the election year. The Committee shall arrange to count the ballots, and notify the President and the elected candidates of the results as promptly as possible, all under procedures as established by the Board.

#### **Article 5: Administration and Duties of Officers**

**Section 1.** The Board of Governors is responsible for the policies and activities of the Club, and shall be governed by these By-Laws and the desire of the members as expressed through proper procedures in accordance with these By-Laws. A simple majority vote shall prevail in deciding all issues and motions, except amendments to these By-Laws and expulsion of a member from the Club. Each member of the Board has one vote. In the event a member of the Board cannot complete his term of office, the Board shall without delay appoint a qualified replacement to serve for the unexpired term. The Board may transact its business at its meetings or by mail or other means of communication, whichever in the opinion of the President will serve its purpose.

**Section 2.** The President shall preside at all meetings of the Club and the Board. He shall appoint all administrative personnel and committees, subject to the approval of the Board. He is a member of all committees, and is responsible for their proper functioning. He shall supervise all activities of the Club in accordance with the policies set forth by the Board. He shall assure the safekeeping of all previous and current records and property of the Club. As chief executive officer of the Club, he shall direct and coordinate all activities of the Club in harmony and always to the advancement of the Club and the promotion of Scandinavian philately everywhere.

**Section 3.** The Vice-President shall preside at meetings of the Club or of the Board in the absence of the President. In case of the disability of the President, he shall take over the duties of that office at the direction of the Board. He shall perform such other duties and functions as the President may direct.

**Section 4.** The Secretary shall keep a record of all meetings of the Club and the Board. He shall issue charters for new chapters, issue certificates to honorary members, prepare and issue timely notices of important events for the Club. He is normally the Membership chairman and as such will handle and process matters pertaining to members in accordance with procedures established by the Board. Should an Executive Secretary be appointed, the Board may delegate to him such duties of the Secretary as may be appropriate.

**Section 5.** The Treasurer shall be responsible for the general funds of the Club, shall collect dues, issue membership cards to all members, maintain a current membership list, publish notices about status of members in the Club's official publication; shall tend to the payment of the obligations of the Club; and shall maintain books and records of the Club's financial transactions in a manner satisfactory to the Club's auditor and in accordance

with common financial practices. He shall maintain such bank accounts and investments in the name of the Club as approved by the Board. He shall prepare an annual financial statement to be presented to the Board by February 1, and shall supervise all financial practices of the various divisions of the Club. Should an Executive Secretary be appointed, the Board may delegate to him such duties of the Treasurer as may be appropriate.

**Section 6.** The Editor shall edit and publish the Club's official publication, known as *The Posthorn*, and any other publications the Club may sponsor, in accordance with policies determined by the Board.

**Section 7.** The Directors shall perform such duties as directed by the President and approved by the Board.

**Section 8.** Should the Club have an Executive Secretary, a Sales Manager, an Auction Manager, a Philatelic Literature Sales Manager, a Librarian, or other appointed officials, they shall each perform their duties in accordance with policies and procedures prescribed by the Board.

### **Article 6: Meetings**

**Section 1.** There shall be at least two major meetings of the Club annually, if possible to be held in conjunction with National stamp exhibitions in the United States. One of these shall be the Annual Convention to be held as early as practicable each year, at which formal reports are to be rendered. Other meetings may be termed national or regional meetings, and are authorized to conduct the business of the Club, provided proper notice to the membership has been given in the Club's official publication.

**Section 2.** Meetings of the Board shall be called by the President as necessary. At least two weeks notice shall be given to all members of the Board of any meeting. Special meetings of the Board may be requested by four of its members, and the President shall then call a meeting as soon as practicable, at a time and place agreeable to the members making the request.

**Section 3.** A quorum for the Annual Convention shall be 25, including at least three members of the Board. A quorum for a national or regional meeting shall be 20, with the same requirement for Board members as the Annual Convention. A quorum of the Board to transact business at its meetings shall be five. In case of mail voting by the Board, a simple majority of the votes received shall prevail, but the total votes shall not be less than the number required for a quorum.

**Section 4.** In order that proper preparatory arrangements can be made for meetings which are hosted by a local chapter, the President shall in good time advise the chapter of the requirements for the meeting including location, probable attendance, the anticipated agenda, and the break-down of expenses between the Club and the host chapter.

### **Article 7: Chapters**

**Section 1.** The Club is to assist and encourage all of its chapters in the promotion of Scandinavian philately anywhere in the world. In order to qualify as a chapter of the Club, the chapter must maintain at least 50% Club members among its membership, and all officers must be members of the Club. A Club member may be a member of more than one chapter, but in such case he may hold elective office in only one chapter at a time.



**Section 2.** New chapters may be formed by a group of at least six Club members who must petition for such chapter status by submitting to the Board an application signed by the Club members desiring to form a new chapter. The application should indicate the area the chapter is to serve, and the recognition of one chapter must not adversely affect the area or activities of another. The Board may change or adjust the area served by existing or new chapters.

**Section 3.** The Club shall not collect dues from any chapter, but may assist chapters financially in the interest of promoting the goals of the Club, and in accordance with the approval of the Board.

**Section 4.** Chapters are entitled to operate under their own by-laws and to collect dues from their members, provided such actions are not in conflict with these by-laws, and are approved by the Board.

#### **Article 8: Amendments**

**Section 1.** Proposed amendments to these By-Laws shall be submitted to the Secretary in writing. They may be proposed by the Board, acting in accordance with its rules of voting, or by the membership at large, in which case they shall be signed by at least six members in good standing.

**Section 2.** The Secretary shall arrange to publish in the Club's official publication all such proposed amendments at the earliest possible date. He shall then arrange with the Chairman of the Committee on Nominations to have the proposal placed on the ballot for the next election of officers, provided there has been time for publication prior to the mailing of the ballots. The Board may direct a special election or authorize a special ballot at other intervals than the regular biennial election, should conditions be urgent.

**Section 3.** Adoption of an amendment shall require the affirmative vote of two-thirds of the valid votes received, but these shall not be less than the requirement for a quorum at the Annual Convention.

## **Scandinavian Stamp Mart**

### **A Service of the Scandinavian Collectors Club**

#### **REGULATIONS**

##### **I. GENERAL**

1. The SCANDINAVIAN STAMP MART is a service for the selling and/or buying of Scandinavian philatelic material only, and is operated **exclusively** for members of S. C. C.
2. While SSM maintains insurance for philatelic material in its custody, it shall not be liable for possible loss or damage to material in the hands of a buyer, who shall be solely responsible for material entrusted to him. SSM will, however, act as agent for a seller in the event of loss.



3. All material to be sold through the Mart must be mounted in the special MART-books, which are available from the MART Manager at 15c each.
4. Sales books of stamps are accepted and retired at the discretion of the MART Manager, who shall not be responsible for classification or pricing of stamps contained therein. When possible, corrections will appear (green ink) for the guidance of buyers.
5. All sales are final, and full payment must accompany the returned MART-booklets (check or money order should be made payable to "Scandinavian Stamp Mart").
6. S. C. C. chapters desiring selections of MART-books must appoint a Chapter Sales Representative who will exclusively handle the chapter's business with SSM.
7. The Chapter Sales Representative is charged with the receipt, handling, and return of MART-books within 30 (thirty) days. He will retain 5% of the net sales amount to defray postage and registry expenses both ways. It is suggested that chapters underwrite any additional expenses in the few cases involving exceptionally large shipments.
8. The MART Manager will not be able to handle want lists for specific stamps. Dealers are usually in a position to provide such service.

## II. SELLERS

1. Sellers will have a 20% service charge deducted when payments are made. There will be no charge for stamps not sold. The service charge reflects sales commission and other expenses essential to the operations of SSM.
2. Stamps should be mounted with NEW hinges in catalog sequence, one stamp to a space. No overlapping or mounting beyond space or page area will be permitted. If one space cannot accomplish this, two or more spaces should be used (for instance for pairs or blocks). If possible, a MART-book should contain material from only one country.
3. Use only BLACK or BLUE INK to mark catalog numbers, catalog values, and net sales prices. Pencil or colored inks are not acceptable (green ink is for the exclusive use of the MART Manager). Sellers must indicate in space provided on the inside front cover of the MART-book which catalog is used for classification.
4. Sellers are advised that buyers are familiar with "Scott" and experience indicates that stamps move well when priced at about "1/3 Scott." Do not try to sell at much higher prices unless a classic rarity is involved. Mint stamps usually sell for a little more. The MART Manager may return books to owner(s) if in his opinion the material is overpriced and might not sell.
5. Sellers must total each row (on line extension) and total each page, as well as furnish the MART Manager with the total value of each book in a separate note. Under no circumstances shall anyone write anything on the outer covers of the MART-books, these being for the exclusive use of the MART Manager.
6. Philatelic covers are desired and permitted with limitations. Due to weight, only 2 (two) 20th century covers are allowed per book (fillers or stiffeners must be removed). However, classic covers, with original letters or explanations, are of course welcome in any quantity. Covers must not extend beyond the edge of the page, and should be mounted securely with mounting corners.

7. New MART-books MUST have a net (retail) value of at least \$10. For insurance and transmittal purposes, a new book must not exceed \$200 net (retail) value.
8. Under no circumstances should blank pages be removed. If not used, just cross them off.
9. Inexpensive or packet-type material does not sell well enough to warrant postage and insurance costs. Damaged stamps (tears, repairs, rounded corners, thins, etc.) are not usually wanted—unless they are desirable varieties or cancels.
10. Retirement of MART-books will be at the discretion of the MART Manager. Retired books will be returned to owner(s) with final accounting. Sellers who wish their book(s) retired prematurely should give the MART Manager reasonable notice.

### III. BUYERS

1. Members receiving shipments of MART-books directly from the MART Manager, and who purchase \$25 or more from a single mailing, pay only postage and registration one way. The MART absorbs the cost of shipping the package(s) to the member in this event.
2. Enter your S. C. C. membership number neatly in the upper portion of each space from which you remove a stamp, and fill out the Sales Report for each book from which you have removed stamps. If you deal with a Chapter Sales Representative, give him the Sales Report(s) with full payment. Members and Chapter Sales Representatives are requested to **double-check** all totals before entering them on the transmittal form. Full payment must accompany the return.
3. Individual members must make returns within 10 (ten) days.
4. Please respect and handle the MART-books with care—as if they were your own.
5. Report discrepancies to the MART Manager on separate paper—do not write anything in the MART-books, except your S. C. C. number in the spaces from which you remove stamps.

## Counterfeit Committee

### RULES FOR S. C. C. EXPERT COMMITTEE

#### Section 1. Organization.

This committee shall consist of a chairman, appointed by the Board of Governors of the S. C. C., and as many examiners as he may find necessary and select, to cover all fields of Scandinavian philately. These examiners shall preferably, but not necessarily exclusively, be selected from members of the S. C. C., and shall be approved by the Board of Governors.



## Section 2. Purpose.

The objective of this committee is to aid in the suppression of faked and counterfeit philatelic material of the Scandinavian countries through the following activities:

a. To identify, record, and describe such material, if possible with photographs and/or color slides, submitted by collectors or dealers, whether or not members of the S. C. C.

b. To publish such descriptions, with illustrations, in the Posthorn, for the guidance of members and others. To publish these descriptions in book form, upon approval of the Board of Governors, when and as the amount of material and conditions warrant, for the further dissemination of this information.

c. To collect and preserve all such material, when donated to the S. C. C. for future use and reference by the Committee and interested members of S. C. C., thereby permanently removing from circulation as much of this material as possible.

d. To cooperate to the fullest extent possible with other expert committees of established philatelic societies, the Division of Philately and Postal History of the Smithsonian Institution, and such other persons and institutions as the Board of Governors may authorize.

e. To assist the members of the S. C. C. in identifying suspect material, if necessary charging a fee sufficient to cover the cost of postage and photographing, unless such material upon being found to be faked or counterfeit is donated to the S. C. C.; such fee, however, to be approved by the Board of Governors.

## Section 3. Procedures.

a. Members are encouraged to submit known fake or counterfeit material to the Committee for recording and publication. The member may, if he wishes, submit his own description of the material, which will be checked by one or more of the examiners before publication. If the member does not submit a description, or if the description as submitted is deemed inadequate, one will be furnished by the examiner(s). Upon publication in the Posthorn, credit will be given to the member submitting the material.

b. Members are encouraged to donate fake or counterfeit material to the S. C. C., for the purposes named in Section 2-c. Such donations will be acknowledged in the Posthorn.

c. Members may submit suspect material to the Committee for examination and an opinion, subject to a fee as covered in Section 2-e. Members are encouraged to donate such material to the S. C. C. conditioned on its being found to be faked or counterfeit.

d. All communications, with or without material submitted, should be addressed to the Chairman of the Committee, who will refer it to the appropriate examiner(s). The Chairman will be responsible for maintaining the files on correspondence, records and descriptions, and donated material, unless the Board of Governors shall designate another person as custodian.

## Carl E. Pelander Award

The "CARL E. PELANDER AWARD" was created in 1968 to perpetuate the memory of Carl E. Pelander, one of our founders. His outstanding characteristic was his willingness to assist his fellow philatelists in all phases of Scandinavian philately.

The award shall be presented at suitable intervals to a member or members of the Scandinavian Collectors Club for outstanding work in furthering the aims of the Club and Scandinavian philately. Recommendations for the award may be made by any member or chapter of the Club. A recommendation shall be accompanied by a written statement of the qualifications of the candidate. All recommendations shall be mailed to the Secretary of the Club.

Prior to any regular meeting of the Board of Directors, the Secretary shall mail notice of all recommendations to the members of the Board, together with copies of the statements of qualifications received by him. The Board may defer action on the recommendations to a subsequent meeting or act at the first presentation of such recommendations. Upon affirmative vote of a majority of the Board, the award shall be made.

A suitable plaque shall be given to the recipient of the award. The presentation shall take place at a regional or national meeting of the Club.
